



Dual Credit Program Application

Purpose

The Dual Credit/Enrollment program enables eligible high school students to earn college credit toward a degree while still in high school.

Procedures

- The student must submit a completed Parkland College Application and the Dual Credit Program Application to the Dual Credit office.
- The student may be required to take an assessment test depending upon the course requested. The Dual Credit office, which is the student's Parkland contact, will assist in making arrangements for testing when necessary.
- The student will be admitted to the Dual Credit program when the Dual Credit Program Application is complete and the student meets stated criteria.

Criteria/Alerts

- High school students may apply to take college-level courses if they are a junior or senior, have the required GPA for the requested course/s, and are at least 16 years of age or older. Students must be currently attending a recognized Illinois high school and be in good standing. Prerequisites, including assessment, must be met.
- Students may enroll in a **maximum of seven college-level dual credit/enrollment credit hours per semester** if approved by the appropriate high school official (i.e., dean, counselor, principal) **and** the chair of the Parkland academic department(s). This does not apply to Dual Credit courses taken at your high school. **Students may not enroll in courses below the "100" level for dual credit/enrollment.**
- Students will be subject to all the requirements, policies, practices, and procedures governing Parkland students, including grading standards and student conduct.
- The type and amount of credit given by the high school toward high school graduation is entirely within the purview of the high school. College credits and grades earned are recorded on the student's Parkland permanent transcript.
- By his/her signature, the student waives the right to privacy and grants Parkland College officials permission to share information regarding that student's performance with his/her parents, legal guardians and/or high school.
- *Dual credit/enrollment students admitted under this program do not qualify for financial aid and are considered course enrollees (non-degree-seeking students). However, performance in dual credit/enrollment courses may have short-term and long-term implications on future financial aid eligibility. - The college or university you plan to attend after high school may or may not accept the dual credit course credits you have earned. Check with your high school counselor or contact your chosen college for specific information.
